Fentem Family Receives Distinguished Family Award From East Central University

During ECU's Centennial Evening of Honors, members of the Fentem family were awarded the Distinguished Family Award for the greatest contribution to the university by one family in the first 100 years of the college. The Fentem family has been closely connected to ECU since 1909 when A.L. "Dad" Fentem became one of the first faculty members at East Central. Now, 100 years later, his great-greatgranddaughter, Ruth Ann Fentem Copeland is graduating with a master of education degree with a school counselor option.

A.L. Fentem was twice voted the most popular professor on the

campus and this year his greatgrandson Brandon Fentem was voted Lindsay's teacher of the year for the second time. It was "Dad" Fentem who chose orange and black as ECU's colors. He taught math, economics and sociology, and directed the first band, wrote the first school fight song, and directed the chorus and quartets. He was still on the faculty when the first men's residence hall, Fentem Hall, was dedicated on June 12, 1937. The Fentems had four sons, A.L. Jr., George, White, and "Doc", who formed the East Central Fentem Quartet. A.L. Jr. was a member of the sub-freshman class of 1909-10

and one of the first football teams. He was later mayor of Ada.

George Fentem was a longtime county school superintendent in Arkansas. Whit Fentem, a quarterback on the football team, met Robert S. Kerr in the Oklahoma National Guard and worked for Kerr's Oil Company from 1928 until his death in 1951. "Doc" attended East Central's Horace Mann School. He formed a band in Canada in the 1920s that later became the Royal Canadians with the Dorsey brothers. He had another big band called the "Doc Fentem Sooners".

COX CITY SCHOOL REUNION

The Cox City School reunion was held on Saturday, June 6, at the University of Science and Arts in Chickasha. More than fifty former students and teachers of Cox City School gathered to recall their years in that school, now departed for a half century. For nearly five hours, the group reminisced about their years at Cox City.

A special tribute was paid to the students and teachers from the class of 1958, the last high school class to graduate from Cox City. My wife and I were honored to be included in that group. That school year 1957-58 was our first year to teach. My wife taught home economics and elementary. I taught English, coached boys and girls basketball, and was principal. Even though we knew that Cox City High School would close at the end of the year, we enjoyed our first year of teaching and appreciated the students we had there. On Saturday night, we met once again with those students from fifty-one years ago.

For my wife and me, the evening was like a trip back in time. One of the first students we met was Buddy Hudson, one of my wife's favorite grade school students. A half century had done nothing to diminish Buddy's wonderful sense of humor. Two stories illustrate that point. My wife attended Cox City her senior year of 1952-53. She was friends with Buddy's sister, Nell. The Hudson family attended the Cox City Baptist Church where her father was the pastor. When she returned four years later to teach, Buddy was a student in her elementary class. Not long after school started, Buddy said to his mother, "I think we are really worrying Juanita. She has a lot more gray hair than she had when she was in high school." But the best Buddy Hudson story is one I have written about in another "Matchbook Memories" column. My wife was practicing a Christmas program, which included all of the grade school students. Just two months earlier, the Russians had launched Sputnik, the first satellite to orbit the earth. The Christmas program was a celebration of the birth of Jesus. In an effort to focus the students' attention on the night of the birth of Jesus, she said, "Look up and just try to imagine the bright, beautiful star that stood above the stable." My wife's plan went wrong when Buddy said, "Look, Mrs. Nye. There's

Sputnik." Buddy told Juanita at the reunion that one of his friends brought The Lindsay News to him at work and told him that his name was in the paper. In that edition was my article where I had told this story. I think his coworkers gave him a hard time. When Buddy left the reunion, he gave Juanita a big hug and said, "I have to go meet with my lawyer to file my libel suit." Buddy is still Buddy.

I was thrilled to visit with three of my former Cox City Comet players. Mary Evelyn Jones, Don Tugman, Leon Wright, and I relived some moments from that season fifty-one years ago. Mary was a forward on my team. Although we did not win a game, those girls were a delight to coach. They worked as hard as any players possible could, but, because of a lack of playing time the year before, they could not win.

Don Tugman was a wiry, athletic guard, who, along with Lindy Justus, could get the ball down the floor, set up plays, and score. Don and I visited for a long time about that year.

Their team was the last one to represent the Cox City Comets.

Leon Wright was our leading scorer. He was a strong,

aggressive player, a team leader, and an excellent jump shooter. In my remarks Saturday night, I told two stories about Leon and our games against Bradley. Since I was from Bradley, I especially wanted to win those games. My friend, Kenny Hays, was the Bradley coach. Our first game was at Bradley. We were only a few points behind in the fourth quarter when a strange thing happened. The referee, whose name I will not mention, called a foul on Leon. Then, almost immediately, he called a technical on him and ejected him from the game. As I ran out onto the floor to ask what happened, he gave me a technical too. I asked Leon what happened, but he didn't know. I asked the referee what Leon said. He said, "He didn't say anything. I just didn't like the way he looked at me." Never before or since have I seen a player ejected for the way he "looked" at an official.

When Bradley came to Cox City, they were undefeated. That game was memorable. The lead changed back and forth many times. I have told the story of the end of that game in an earlier column. I will summarize the ending like this. The score was tied with only a few seconds left. The benches were up on the stage in the Cox City gym. I was standing on the steps leading down to the floor. Walt Snedeker was one of the officials. He had warned me not to say another word and to stay off the floor. As I leaned around the front of the stage to see the corner of the floor, I slipped, fell down the steps, and slid out onto the floor. Walt turned and saw me out on the basketball floor. As he raised his hand to call a technical, I held up both hands and asked him to wait. When I told him how I came to be out on the floor, he began to laugh. He thought I was lying, but he didn't call the technical. A few seconds later, Leon Wright hit a game-winning shot. That game was the highlight of my year at Cox City. On Saturday night, I enjoyed visiting once again with Leon, one of the best players I ever had and one of the

most pleasant to coach.

Juanita and I sat at the banquet table with Shirley Cunningham Tillman and her daughter, Karen. When their class of 1953 celebrated their 50th reunion, several members of the class met at Shirley's house at Lindsay for lunch. Don Cunningham, John Harold Hanley, Juanita, and Shirley spent the afternoon making posters of their families and sharing stories of the years past. Shirley was a wonderful host. They all enjoyed a memorable reunion that evening.

My wife and I enjoyed visiting with other long-time friends. I had a wonderful visit with Lee Roy Riley, my college roommate. We enjoyed visiting with Bill and Joy Riley, longtime dear friends from Bradley and Cox City. We visited with Marian Cunningham, Virginia Cunningham, Nell Hudson, Neta Lindsey, Gladys Justus, Cotton and Betty Todd, Gaynell Worley Tugman, Ruby Worley, and many others we have known through the years. Even after more than a half century, those years came alive once more. We look forward to the next reunion, 2011, when we hope to meet with the Cox City School people once again.

(Continued from page 1) A.L. Fentem Jr.'s son, Jack Fentem, was on the ECU football team during the 1946 season. He later was the president of the Ada School board. All three of Jack's sons attended ECU. The youngest, Jeff, was a music major and teaches music in Texas. The middle son, Don, was a business major and is a hospital administrator in Texas. The eldest, Brandon, graduated from ECU with a bachelor's degree in education and history in 1975 and a master of education degree in 1980. He was the first president of ECU's Campus Crusade for Christ and he assisted with Chautauqua performances at ECU in 1994.

Brandon Fentem's wife Becky was one of ECU's first Oklahomans, a highly acclaimed singing and performing group. She received her bachelor's and master's degrees in education from ECU. Two of their daughters attended ECU for a short time, and daughter Ruth Ann Fentem Copeland will receive her master's degree this summer. Her husband, Charles "Chuck" Copeland, a member of ECU's 2004 Conference Championship baseball team, also has bachelor's and master's degrees from ECU. He teaches math and coaches baseball at Cushing High School.






