Dr. Marilynn Hines Leaving Main Clinic

According to Carrie Arter, health care service industry. office manager of the Main Clinic, Dr. Marilynn Hines will see her last patient in Lindsay December 23, 2008. After 16 years of service in Lindsay, Dr. Hines is taking down her shingle.

Dr. Hines is leaving her practice due to continued cut backs to health care service providers by insurance companies, Medicare and Medicaid. It has become economically unfeasible to continue private practice in rural Oklahoma without the fiscal support of a hospital or other

Dr. Hines' Physician Assistant, Jere Claunch, PA-C, will continue to see patients and is interviewing for over sight by a new physician. PA's are medical service providers who examine, diagnose, and treat patients under the direct supervision of an MD or DO.

As of publication time, Jere had narrowed it down to three possible candidates and will keep the community informed of further developments as they arise

According to Coach Wilson, we can expect very little change except to build on the program established by Dan Chapman. He is thankful to be here and for the opportunity to continue the tradition. Plans are to establish team goals prior to the first game against Wynnewood and to expect improvement throughout the three phases of the season: before Christmas, after Christmas, and the play-offs.

His philosophy is to utilize the quality in depth of players this year's team possesses by pushing the transition offense. Fresh players, pressure defense, and fast tempo should create organized chaos for the quick, easy shots. And when that is

The Lindsay Leopards began deliberate offense, working while maintaining control of the ball more minutes than the opponents.

This year's Leopards have a lot of depth, with talented, athletic voung men ready to contribute their skills in a winning season. Their work is set before them as they adapt to a different style of play under Coach Wilson, but improvement is expected in shooting and defense as the year progresses. It is always tough when 11 of 24 players come off the football field, straight to the hardwood to perfect their shots and footwork in a limited amount of time.

Leopards are loaded with 10 seniors. Three returning starters include Doug Ezell, Jesi Millsap, and Jordan Lukens. Ezell has the best perimeter shot. Millsap is very physical, plays bigger than his height, and is an exceptional leader, recovering from a football injury. Big things are expected from Lukens as a carryover from his football success. Josh Christie is very quick and an improved shooter. Avery Robinson will provide depth as a versatile player. Tim Hamilton, currently out with an injury, is very athletic and will provide leadership in the point guard position. Keaton Peery runs well and has excellent jumping skills. Jacob Harris, who saw a lot of action last year, returns to contribute his three point shooting talents. Tim Bohannon, is the mountain in the middle, with a good understanding and attitude about the game, and has good hand for his big stature. Brandon Selman is another good shooter with a winning spirit.

SMALL TOWN CAFES PART II

When Double A Perry closed his cafe in Bradley near the end of World War II, Dave and Esther Bomhak opened their cafe. Bomhak's Cafe was located in the last building on the south end of the row of rock buildings on the east side of Main Street. The cafe occupied the front of the building, and the family lived in the back of the building.

The cafe served the traditional cafe food for those years: hamburgers, fries, stew, chili, and plate lunches. A counter with stools ran down the center of the cafe. Several booths lined the south wall. Near the front on the south side was a jukebox, which featured a mix of the most popular country and pop song hits. One or two pinball machines stood near the front along the north wall. Near the large front window, an open flame gas heater drew people around it in cold weather. In the front window of the cafe was a former display shelf that became a window seat for people who were just loafing in the cafe. That window

1950s. My brother, A.W., spent many hours there courting Mary Ella Bomhak, whom he later married. The veterans returning from World War II found Bomhak's Cafe a convenient place to re-enter society after years away at war. My brother, Jim, and his friend, Ralph Morris Renner, spent long hours there with Jonnie Etta Hollis and Patsy Ruth Beverly, whom they later married. Sometimes some of the veterans would get loud and rowdy after too much to drink outside before coming into the cafe. Mrs. Bomhak would sternly ask them to leave. They always

I recall a cold night in 1950 after a Bradley basketball game. The cafe was crowded with Bradley students. Hoss Crowe and I sat in a booth listening to the jukebox play Bob Wills' "Faded Love." Cack Roller was attacking the pinball machine in the corner. I still remember the comfortable feeling as the warm cafe, the friends, and the music provided a haven from

A few days broomcorn Johnnies eating were still amazed at how many had to be finished in one hour for another hot afternoon in the sweltering broomcorn fields.

Bomhak's Cafe closed not long before the Bradley tornado of March 13, 1953, which swept those rock buildings away. I was away in the Army when that tornado destroyed much of the Bradley I knew. But my younger school years are inextricably linked in my mind to that small town cafe in Bradley. I can still close my eyes and relive the sights, sounds, and smells that marked that social center of my boyhood years. Sometimes my sister-in-law, Mary Ella Bomhak Nye, and I reminisce about those years, that place, and the friends who shared those wonderful times with us.



Oklahoma Ranks Fifth For Board Certified Teachers

State Superintendent Sandy Garrett today congratulated Oklahoma teachers for elevating the state to No. 5 in the nation in the percentage of its teachers - nearly 6 percent - who are National Board Certified. Only 2 percent nationally have the advanced credential.

The National Board for Professional Teaching Standards (NBPTS) today released the names of teachers (www.nbpts.org) who were awarded national certification for 2008 and indicated Oklahoma had the nation's 8th highest rate of increase of National Board Certified teachers. Moreover, with 324 new National Board Certified teachers, Oklahoma ranks 10th in the nation in the total number (2,307) of its teachers with the certification.

"We had a 12 percent increase in nationally certified teachers in one year, and National Board teachers now comprise nearly 6 percent of our teaching force," Garrett said. "This is quite an accomplishment. Only seven states can say more than 5 percent of their total teaching force is National Board Certified and Oklahoma is of them!"

Garrett lauded the National Board incentives program funded by the state Legislature as the engine for fueling Oklahoma's progress with National Board certification. The program provides an annual \$5,000 bonus to any classroom teacher who holds the certification and works full-time in a public school. The certification is valid for 10 years before a teacher needs to reapply. State funds also provide for scholarships to the Education Leadership Oklahoma program, which assists teachers in applying for national certification - a process that takes most a year to complete.

The majority of National Board teachers in Oklahoma - nearly 60 percent -work in high-poverty, Title I-eligible schools. The districts with thehighest number of National Board teachers are Tulsa (131), Edmond (112), Norman (107), Moore (93) and Oklahoma City (93). This is the first year Oklahoma City was among the state's top 5 school districts in the number of National Board teachers. Oklahoma City edged the Putnam City school district for the 5th position.

"As one of the early members of the NBPTS and as Oklahoma State Superintendent, I congratulate our newly certified National Board teachers and encourage all Oklahoma teachers to consider pursuing this worthy goal," Garrett said. "It is a time-consuming, rigorous process, to be sure, but it makes good teachers even better teachers and that's a winning situation for students and schools."





OBITUARY John E. Frady 1921-2008



Reverend John E. Frady, 87, Norman, was born May 10, 1921, to John Edward Sr. and Ollie Mae Frady in Leonard, OK.

He died in his home, surrounded by his loved ones, and moved to his heavenly home Wednesday, November 26.

Reverend Frady grew up in Bixby, OK, graduated from Bixby High School, went to Business College, continued taking college classes and was an avid lifelong learner.
