

# **Voters Need To Apply Now** For 2009 Absentee Ballots

Voters in Garvin County who want absentee ballots mailed to them for elections in 2009 should apply now, according to County Election Board Secretary, Cathy Brinley.

Voters may apply for absentee ballots in person at the Garvin County Election Board office, by mail, or by fax. Any registered voter may ask for The letter must contain all the absentee ballots for a specific following information. election or for all elections held during the calendar year.

Voters who are physically incapacitated and voters who district in which you reside. care for persons who cannot be left unattended may apply for absentee ballots only by mail or by fax.

Absentee ballot application

forms are available at the County Election Board office located at the County Courthouse, Room 8, or they can be down loaded from HYPERLINK "http://www. elections.state.ok.us/" http:// www.elections.state.ok.us/

Or, instead of using the form, you can write a letter to the County Election Board Secretary.

Your name, residence address, and signature.

The name of the school

The name of your city, if you live inside city limits.

The address where you want your ballots mailed.

The type of request you

are making. Voters who are in nursing homes, voters who are physically incapacitated, and voters who care for persons who cannot be left unattended should mention this in their request. This information activates special procedures that will make voting and returning absentee ballots easier for these

The election or elections for which you want ballots. You may ask for ballots for all the elections for which you are eligible during the entire calendar year.



# Matchbook Memories

#### **SMALL TOWN CAFES PART III**

In the late 1940s and early 1950s, Stony Drennan's Cafe stood in the middle of Alex on the west side of Main Street. Birdie Drennan, Stony's wife, ran the cafe. Stony had a barber shop next door, and he helped in the cafe when he was not giving someone a haircut or a shave. That cafe was a haven for several of the Bradley boys. We hung out there, eating hamburgers and fries, playing the jukebox, and talking to the Alex girls. Sometimes we arrived there on hot Saturday nights after putting in a full day in the broomcorn fields. Sometimes we spent long hours there on cold nights with the freezing north wind howling down the deserted Main Street outside. On those nights, the warm cafe was a kind of refuge as the jukebox played Carl Smith, Hank Williams, Lefty Frizzell, Jo Stafford, and Kay Starr. The open flame gas heater near the booths created a pleasant warmth as we danced to the music.

The enticing smell of hamburgers frying filled the cafe.

Wearing a white shirt and a long white apron, Stony would fry the hamburgers, and Birdie would carry the food. Mollie Sue, their teenage daughter, helped in the cafe, but mainly she kept the jukebox playing and entertained us with her jokes and lively chatter. In the winter months when money was scarce, Mollie Sue would be sure that we did not have to pay for our hamburgers and cokes. She dated my good friend, Hoss Crowe, and we always had money, thanks to Mollie Sue. Her unfailing good humor and her hearty laugh made that cafe a popular place with the Bradley boys.

Sometimes we would get a little too rowdy and loud. With a few quiet words, Birdie could settle us down. But we never were rowdy and loud when her brother came in for a hamburger and coffee. Her brother, DeArthur Wilson, was the Grady County sheriff. He was an older man in those years, but he was still a commanding presence. He would enter the cafe quietly, a thin man always dressed neatly in western pants, boots, a white shirt, and a conservative western Stetson. His pistol rode high on his hip, a pistol that we knew he had used to deadly effect. I knew of two Bradley men he had killed. DeArthur was part Indian and spoke seldom and softly, but when he spoke, people listened. We would watch as he sat at the counter, talking quietly to Birdie. As soon as he left, we would go back to our boisterous behavior.

I recall a small vignette from a half century ago that has remained in my mind as a classic example of loneliness. It was a late Sunday afternoon on Labor Day weekend in 1951. The Korean war was raging, and we were all waiting to

go into the Army. As Boyd English, Hoss Crow, and I walked into Drennan's Café, the only customer was a young soldier from Fort Still. He sat alone in a booth, smoking cigarettes and playing records on the jukebox. The jukebox was playing "A Heartsick Soldier on Heartbreak Ridge," a song about a soldier in Korea who had just received a Dear John letter from his girlfriend at home. The young soldier had apparently hitchhiked to Alex to get away from the Army for a few hours. As Boyd, Hoss, and I drove away, the young soldier was sitting slumped on the bench in front of the cafe, staring into the distance. In the hot late afternoon sun, the Main Street of Alex was totally deserted except for the soldier sitting alone, thinking about who knew what.

Hoss Crowe and I were sworn into the United States Army on December 12, 1952. On the night of December 11, we sat in the back booth of Drennan's Cafe with Mollie Sue and Kathleen Cotton. No one else was in the cafe as the evening grew late. From the jukebox came the sounds of Kay Starr singing "Wheel of Fortune." As I listened to that song, I realized that I might never again see that place. I wondered what my wheel of fortune would

bring to me. Last week on the night of December 11, I thought back to that night fifty-six years ago and traced the twists and turns my life has taken since that night in Drennan's Cafe over a half century ago. Hoss and Mollie Sue are gone from this earth. My life has taken turns that I could never have dreamed of in my younger years. But, in my mind, Drennan's Cafe still remains as it was so long ago. I can still hear Mollie Sue's laughter, see Hoss slouched in the corner of the booth, and recall Kathleen's breezy banter. Through the diaphanous mists of time, I see Drennan's Cafe as it was then on that last cold December night before the Army changed my life

Oklahoma Cooperative Extension Service in cooperation with the Southern Region risk Management Education Center will present Annie's Project, beginning January 20, 2009, at the Nora Sparks Warren Library in Pauls Valley.

Annie's Project is designed to empower farmwomen to manage information systems used in critical decision making processes and to build local networks throughout the state. The target audience is farmwomen with a passion for business and involvement.

Annie was a woman who grew up in a small farm community with a goal to marry a farmer and she did. Annie spent her lifetime learning how to be an involved business partner with her farm husband. Together they did great things, but it wasn't easy. This is *Annie's Project* – to take her life's experiences and share it with farmwomen living and working in a complex, dynamic, evolving business environment.

Farm women will receive training for managing information in the areas of: (1) Financial Records, (2) Production Records, (3) Marketing Plans and Risk Management, (4) Legal/Regulation Records and Documentation, and (5) Human Resources and Time Management.

This women's empowerment program will be offered in six 3-hour sessions from 1 to 3 p.m. beginning January 20 and continuing each Tuesday through February 24. The cost of the program \$50 per person.


#### THANK YOU






